REQUEST EARLY OR ABSENTEE BALLOTS: You or your family member can request early or absentee ballots at any time during the year of the election in person, in writing, by telephone, email, or online at <a href="https://mvp.vermont.gov/">https://mvp.vermont.gov/</a>. The latest you can request ballots for the 2025 Annual Meeting is the close of the Town Clerk's office on Monday March 3, 2025. (Any other person authorized by you who is not a family member must apply in writing or in person for a ballot for you.)

## WAYS TO VOTE YOUR EARLY BALLOT:

You may vote in the town clerk's office before the deadline.

You may take your ballot(s) out of the clerk's office and return in same manner as if the ballots were received by mail.

You may have ballot(s) mailed to you, and mail or deliver it back to the clerk's office before Election Day or to the polling place before 7:00 p.m. on Election Day.

If you are sick or disabled before Election Day ask the town clerk to have two justices of the peace bring a ballot to you at your home. (Ballots can be delivered on any of the eight days preceding the day of the election or on the day of election.)



## **INSTRUCTIONS TO VOTERS**

- Use BLACK Pen to fill in the oval. DO NOT USE PENCIL.
- To vote for a person whose name is printed on the ballot, fill in the oval to the right of the name of that person.
- To vote for a person whose name is not printed on the ballot, write the person's name in the blank space provided and fill in the oval to the right of the write-in line. Please use block letters and stay within the box provided for write-ins. Do not vote for more candidates than the "VOTE for NOT MORE THAN #" for an office.
- If you make a mistake, tear, or deface the ballot, return it to an election official and obtain another ballot. DO NOT ERASE.
